Rider Age

Current

Section 3.1, Chapter A, Paragraph 6, Page 136

6. Age Limitations
 - a. With the exception of youth competition, the age of the rider is determined as the date of the event.
 - b. Unless stated otherwise in Section 3.3, in all events, a rider must be at least 12 years old to ride a motorcycle above 86cc displacement.
 - c. Riders must be at least 14 years old to ride motorcycles above 250cc displacement.
 - d. Riders must be at least 17 years old to ride twin cylinder motorcycles.
 - e. See ATV Section 3.4 for ATV age limitations.

Proposed (Proposed changes in **bold**)

Add to Hillclimb section:

3.1.A.30 (New) The minimum age for amateur hillclimb riders is 12 on any motorcycle up to 250cc. In all events, a rider must be 14 or older to ride any motorcycles above 250cc. The age of the rider is determined as of the date of the event, except in youth competition.

***Remainder or chapter to be renumbered: 30 moves to 31, 31 to 32 and so on to add this rule as 30.**

Reason

Flat track commission changed the wording for Track Racing and it affects Hillclimb discipline that falls under the same general rules in Section 3.1 events, a rider must be 14 or older to ride any motorcycles above 250cc. The age of the rider is determined as of the date of the event, except in youth competition.

Section 3.6, Chapter A, Paragraph 21, Page 183

21. AMA Pro Racing Hillclimb Pro Sport-licensed riders can race at the AMA Hillclimb Grand Championship

Proposed (Proposed changes in **bold**)

21.

- A. AMA Pro Racing Hillclimb Pro Sport-licensed riders can race at the AMA Hillclimb Grand Championship
- B. AMA Pro Racing licensed riders, or any riders holding a professional motorcycle racing license, or from another country, must wait one full year after their professional license expires to be eligible for AMA Amateur Hillclimb Grand Championship or year-end district awards. An AMA appeal process is available.**
- C. AMA Pro Racing Hillclimb Provisional License will allow a current amateur hillclimb competitor, with the qualifications listed below, to compete in up to, but no more than, 1 race less than 50% of the AMA Pro Racing Pro Hillclimb sanctioned events, while maintaining their amateur status in American Motorcyclist Association-sanctioned events. If a rider elects to compete in 50% or more of the races, their AMA Pro Racing provisional license will be upgraded to professional license and amateur status removed.**
 - 1) Riders who have finished within the top 30percent in the 450cc-600cc-750cc open classes only at the previous two seasons the AMA Amateur Hillclimb Grand Championship.**
 - 2) Riders must be 16 years old when applying.**
 - 3) Must comply with the AMA Pro Hillclimb Rulebook.**

Section 3.6, Chapter A, Paragraph 26, Page 184

Rider Exhibition limitation

26. Riders cannot enter more than 4 classes at any given event. Exhibition classes do not count towards the 4 class limitation except at the Grand Championship.

26. Riders cannot enter more than 4 classes at any given event. Exhibition classes do not count towards the 4 class limitation **except at the Grand Championship**.

Reason

The rule was not intended to have the statement including Grand Championships in the limitation. Inadvertently added from a flat-track update.
