



# 2021 RECREATIONAL Road Rally Sanction

## Deadlines

- Sanctions must be received at least 14 days in advance of the event. Sanctions may not be granted if received less than 14 days in advance. If a late sanction is granted, a fee of \$25 will be assessed.
- Sanctions submitted at least 90 days before the event will be listed in *American Motorcyclist* during the magazine month in which the event is scheduled.
- Post-event paperwork (recreational event report and electronic participant list) should be sent to the AMA within 14 days following the event.
- Follow the preferred insurance program's requirements for the injury report and waiver procedures.

## Insurance

- Use of an AMA-approved insurance program for event liability insurance is required. AMA requires event insurance to be in place at least 10 days prior to the event. Insurance for your event will be issued only upon receipt of your full insurance premium payment.

## Marketing

**Rally Definition:** A road riding event that includes at least one guided or self-guided ride, vendors and/or other non-sanctionable activity such as a swap meet, concert or more.
