### Additional Coverage & Terms

- Multi-day Events: Day 1 = full event rate; Days 2+ = 50% event rate for each additional day.
- Multiple Events on Same Day: One full event rate for highest category covers all events for that day.
- Camping, Set Up, Teardown: Day prior and/or day after event are included at no charge. Additional day coverage is **\$40 per day for 1M**.
- Practice: Day before event = 25% of event rate and ambulance must be on site for practice for competition events.
- Event attendance subject to audit.
- Misreporting may result in loss of coverage, sanction privileges, and fines.
- In order to receive credit for any event changes or cancellations, you must notify within 30 days after the original event date.

*This form should be submitted after receiving your sanction authorization. Insurance is only valid if the sanction has been approved. AMA requires event insurance to be in place at least 10 days prior to the event.*
